

**Summit Water Distribution Company - Assessments and Fees**  
**Adopted by the Board of Directors - March 24, 2023**  
**Effective April 1, 2023**

**A. Title Transfer Fee** A \$150 administrative fee applies to all share title transfers.

**B. Late Fees** Any assessment or fee not paid by the due date will be charged a late fee of \$15.

**C. Disconnect Fee** As specified in our policy a shut off of water service will result in a fee of \$210. Accounts with Standby Shares will be assessed a fee of \$15 per share, or portion thereof.

**D. Meter Read Fee** A fee of \$50 per month will be charged for manual read meters.

**E. Hydrant Meter Rental Fee** A fee of \$300 per month will be charged for hydrant meter rentals, plus \$20/1,000 gallons used, and a deposit of \$2,000.

**F. After Hours On-Site Visit** A fee of \$105 per occurrence will be charge for after hours on-site visits.

**G. Standby Fees - Class B Inactive**

Begins when property is purchased. Pays Weber Basin and Davis Weber Assessments and administrative expenses.
